HRD Board of Directors - Ad Hoc Personnel Committee Memo

The committee would like to provide an update on the status of the General Manager search process and seeks the Board's advice on next steps in the candidate interview process.

Search Update:

The Ad Hoc Personnel Committee posted the General Manager job in early August and the first screening of applicants was September 9. The committee identified five candidates who met the job qualifications and completed phone interviews with four candidates. One candidate withdrew their candidacy, due to a change in personal circumstances. The committee recommends moving the four candidates screened forward in the interview process.

Recommended Next Steps:

The Ad Hoc Personnel Committee recommends convening a panel of 4-5 Highlands community members to serve on an interview panel for a round of virtual interviews the week of October 3. The committee recommends a virtual panel because some candidates are from out of the area. **If Board Members would like to nominate community members to sit on the interview panel, please bring those names to the Sept. 22 Special Meeting.**

The committee then recommends that we then move 2-3 candidates, based on feedback from the interview panel, forward for in-person interviews with the Board of Directors the week of Oct. 10. The District will potentially need to facilitate travel and lodging for out of town candidates.
